In consideration of acceptance of my entry, I, for myself and anyone entitled to act on my behalf, waive and release, the event directors, Big Sky Ski Education Foundation ("BSSEF"), its members, board members and all persons and organizations affiliated with the BSSEF and/or the BSSEF Turkey Trot event, including but not limited to the West Fork Homeowners Association and its property owners and members, South Fork Homeowners Association and its property owners and members, and all sponsoring associations, individuals and businesses from any and all liability arising from illness, injuries, damages and even death, I may suffer as a result of my participating in this event. I grant permission for all of the foregoing to use any photographs, motion pictures, videos and recordings of this event for any legitimate purpose. I understand that entry fees are non-refundable. I understand and agree to the terms of this waiver and release statement.

1. *Waiver. YOU UNDERSTAND THAT PARTICIPATION IN THE EVENT IS POTENTIALLY HAZARDOUS, AND THAT A REGISTERED PARTY SHOULD NOT PARTICIPATE UNLESS THEY ARE MEDICALLY ABLE. 2. *Limitation of Liability; Disclaimer of Warranties. BSSEF SHALL NOT BE LIABLE FOR ANY DIRECT, INDIRECT, INCIDENTAL, SPECIAL OR CONSEQUENTIAL DAMAGES and/or injuries.*
3. *Indemnification. You agree to indemnify and hold BSSEF, its agents, sponsors, members and board members harmless from and against any and all damages, costs, claims or demands, including reasonable attorneys' fees, made by any third party due to or arising from or relating to your participation in BSSEF activities or events. BY INDICATING YOUR ACCEPTANCE OF THIS AGREEMENT AND WAIVER, YOU ARE AFFIRMING THAT YOU HAVE READ AND UNDERSTAND THIS AGREEMENT AND WAIVER AND FULLY UNDERSTAND ITS TERMS.
